LAHDBC - P2P - POLA Update

We have maintained consistent communication with both Pathway 2 Podium and the Port of Los Angeles, who remain committed to returning water sport clubs to the water as soon as possible.

Permission was granted for us to enter CBYC to clean and turn over our boats, and both the Port of Los Angeles and Pathway 2 Podium continue to work collaboratively with us throughout this process.

All requested documentation has been submitted, including the Port permit application, insurance policy, boathouse inventory, facility usage details for Sunday and Wednesday practices, and verification of our registration with the California Secretary of State.

We are currently in the process of updating our insurance policy to fully satisfy Port of Los Angeles requirements. We appreciate everyone's continued input, support, and patience as we work toward resuming paddling operations at CBYC.
